

De-Population: Viruses

No Flesh Saved Alive

The last two commentaries I've given have been on the subject of what the elite are planning to do or have been doing about what they claim is the overpopulation of the earth ["Overpopulation" and "De-Population: Vaccines"]. In my last commentary, I talked about some of their de-population methods. In that case, I spoke about vaccines, and today I want to speak to you about viruses—de-population using viruses. The reason I am giving these is not to depress you or not to make you fearful of what's coming, but so that you'll really have an appreciation for God's way of life and really detest man's way of life and what he has done to this world, what he is doing, and what he's willing to do to his fellow human beings.

Authors of the books of the Bible usually present illness from a non-technical view. They see outside forces as playing a significant part in the cause of disease. Sometimes the cause of disease is explicitly said to be evil in origin, but nevertheless allowed by God. The sufferings of Job are explained in this way in Job 2:1-8. Another example is the apostle Paul, who describes his thorn in the flesh as a messenger of Satan (II Corinthians 12:7).

With this in mind, deadly viruses and bacteria today are sometimes weaponized by evil design and used to deliberately murder people. They could be said to be messengers of Satan, and there is a reason God allows such horrible things to be designed by evil people. They're part of the inherent penalty for the sins of a rebellious world.

Let me give you some examples of bioweapons and their use in history. The first one, anthrax, perhaps the best known biological weapon, is caused by the by *bacillus anthracis* bacterium. Research to weaponize anthrax was performed by the UK during World War II. The UK produced millions of cattle cakes, spiked with anthrax, to retaliate in case the Nazis would have used biological weapons. After field trials with anthrax bombs on Renard Island in Scotland, this isle was lethally contaminated and off limits for any human being for nearly 50 years.

The next one: plague, caused by the bacterium *yersinia pestis*, was one of the first infectious diseases that have been used for military purposes. In 1346, after three years of blockading the city of Caffa, the Tartars catapulted their plague victims into the city, causing a deadly epidemic within weeks.

The next one: smallpox. It's said to have been globally eradicated in 1977. However, smallpox virus called variola, is still kept in research institutions. Biowarfare with smallpox goes back to the 18th century, when the British sold horse blankets contaminated with smallpox to Native Americans in the USA. The former USSR is alleged to have produced weaponized smallpox virus in a facility called Vector near Novosibirsk. As smallpox vaccinations were stopped some 20 years ago, especially youth are extremely vulnerable to smallpox today.

Ebola, one of the most deadly viruses, is a potential bioweapon. The Japanese Aum sect known for the poisonous gas attack on Tokyo Metro allegedly attempted to get hold of a Ebola samples by sending cult members to Zaire during an Ebola outbreak.

The next one, foot-and-mouth disease, is an example of an anti-animal weapon. Biological weapons are not restricted to human pathogens; any living agent that is used for hostile purposes, regardless of its origin and target, is considered a biological weapon under the Biological and Toxic Weapons Convention, also known as the B.T.W.C.

Also, anti-crop bio weapons have been developed. For example, the USA had an arsenal of 900 kilograms of a rice pathogen during the Vietnam War, before the US biowarfare program was said to be dismantled in the late 1960s.

The last one I have in the list here is toxins, also covered by the BTWC. Toxins are highly lethal substances that are usually produced by living organisms such as fungi, algae or bacteria. One of the most deadly toxins known to humankind is botulinum toxin, which has been weaponized in the past in offensive biological weapons programs.

In the last 20 years, there has been a deadly string of horrible viruses that have been proven to be created in a laboratory. Several news agencies within the in the past month have carried a story about a man-made supervirus that critics say could kill half of humanity. According to the media who are still carrying the story as of yesterday, a virus with the potential to kill up to half the world's population has been made in a lab. Now academics and bioterrorism experts are arguing over whether to publish the recipe, and whether the research should have been done in the first place. The virus is an H5N1 bird flu strain, which was genetically altered to become much more contagious. It was created by Ron Foucher of the Erasmus Medical Center in Rotterdam, the Netherlands, who first presented his work to the public at an influenza conference in Malta in September. The research work was funded at least in part by the United States.

Foucher said the strain circulates in animals, particularly birds, but rarely affects humans. In the 10 or so years since bird flu first emerged in Asia, fewer than 600 cases have been reported in humans. But the H5N1 strain is particularly vicious, killing roughly half of patients diagnosed with it. What stops it from becoming a major threat to public health is that it does not readily transmit from human to human, or at least it did not until now. A genetic study showed that the new, dangerous strain had only five mutations compared to the original one, and all of them were earlier seen in a natural environment, just not all at once. Foucher's strain is as contagious as the human seasonal flu (which kills tens of thousands of people each year) but is likely to cause many more fatalities if released.

"I can't think of another pathogenic organism that is as scary as this one," Paul Kein, a microbiologist who has worked on anthrax for many years, told *Science Insider*. "I do not think anthrax is scary at all compared to this.

To implement their final solution to depopulate 5.5-6 billion people from the Earth, the world's elite are using biotechnologies and nanotechnologies to create bioweapon viruses and toxins, creating a global kill off pandemic through which only they will have the cure. In their feverish lust to commit mass murder and ethnic cleansing, members of the elite are quite often willing to state that fact. In the August 1988 forward to his biography *If I Were an Animal*, the British Prince Philip (who is actually of German descent and was a Nazi sympathizer) wrote, "In the event that I am reincarnated, I would like to return as a deadly virus in order to contribute something to solve overpopulation." This is just one of many of the on-the-record statements where Prince Philip has advocated his desire to cull the "surplus" of human population.

Another respected individual who embraces the notion that humans are a virus that should be wiped out en masse for the good of Mother Earth is Dr. Eric R. Pianka, an American biologist based at the University of Texas in Austin. During a speech to the Texas Academy of Science in March 2006, Pianka advocated the need to exterminate 90% of the world's population through the airborne Ebola virus. The reaction from scores of top scientists and professors in attendance was not one of shock or revulsion; they stood and applauded Pianka's call for mass genocide. Pianka's speech was ordered to be kept off the record before it began as cameras were turned away and hundreds of students, scientists, and professors sat in attendance.

Saying the public was not ready to hear the information presented, Pianka began by exclaiming, "We're no better than bacteria," as he jumped into a doomsday Malthusian rant about overpopulation destroying the Earth. Standing in front of a slide of human skulls, Pianka gleefully advocated airborne Ebola as his preferred method of exterminating the necessary 90% of humans, choosing it over AIDS because of its faster kill period. Ebola victims suffer the most tortuous deaths imaginable as the virus kills by liquefying the internal organs. The body literally dissolves as the victim writhes in pain, bleeding from every orifice.

Pianka then cited the "peak oil" fraud as another reason to initiate global genocide. He said, ". . . and the fossil fuels are running out, so I think we may have to cut back to two billion, which would be about 1/3 as many people." Later the scientist welcomed the potential devastation of the avian flu virus and spoke glowingly of China's enforced one-child policy before zestfully commenting, "We need to sterilize everybody on the earth." At the end of Pianka's speech, the audience erupted, not in a chorus of boos and hisses, but to a raucous reception of applause and cheers as audience members clambered to get close to the scientist to ask him follow up questions.

Pianka was later presented with a Distinguished Scientist award by the Academy. Pianka is no crackpot; he has given lectures to prestigious universities worldwide. Indeed, the notion that the Earth's population needs to be drastically reduced is a belief shared almost unanimously by academics across the Western Hemisphere.

Investigative Journalist Wayne Madsen has reported that a top scientist for the United Nations, who has examined the outbreak of a deadly Ebola virus in Africa as well as HIV/AIDS victims, concluded that H1N1 possesses certain transmission vectors that suggests that the new flu strain has been genetically manufactured as a military biological war weapon. The U.N. expert believes that Ebola, HIV/AIDS, and the current H1N1 swine flu virus are biological warfare agents. Straight from the U. N. Straight from a medical doctor.

Why would God allow such horrible sickness to be designed and used against the world, including the descendants of the ancient Israelites scattered around the globe? Well, God tells us why through Moses, where he warns the children of Israel and their descendants that we must obey Him to revere His name.

Deuteronomy 28:58-62 "If you do not carefully observe all the words of this law that are written in this book, that you may fear this glorious and awesome name, THE LORD YOUR GOD, then the LORD will bring upon you and your descendants extraordinary plagues—great and prolonged plagues—and serious and prolonged sicknesses. Moreover He will bring back on you all the diseases of Egypt, of which you were afraid, and they shall cling to you. Also every sickness and every plague, which is not written in this Book of the Law, will the LORD bring upon you until you are destroyed. You shall be

left few in number, whereas you were as the stars of heaven in multitude, because you would not obey the voice of the LORD your God.

Well, that is a warning and a prophecy to the Israelitish peoples today. Having mercifully warned us, it may be that God allows these genetically manufactured biological weapons to be used against the people of the world, including the U.S., Canada, the U.K., Australia, and the other Israelitish nations, along with the rest of the world, for the reason that Moses declared.

Sometimes God allows these evil messengers of Satan in the form of sickness to negatively affect us so that we and others might learn lessons from them.
