The Sexual Floodgate Is Open!

Pedophilia Martin G. Collins Given 13-Feb-16; Sermon #1308c

I want to talk to you today about something that makes me absolutely furious! Satan's evil plan to destroy families is continuing to be executed. The wicked trend is set. The slippery slope has been well-greased. The flood gates of degenerate sexual immorality have been opened.

Using the same tactics used by "gay" rights activists, pedophiles have begun to seek similar status, arguing that their desire for children is a sexual orientation no different than heterosexuals or homosexuals. Pedophiles have a strong, almost irresistible desire to sexually assault and rape children. (Please forgive me for the abrupt words.)

According to Dr. Mace Knapp, Nevada State Prison Psychologist, "The serial killer has the same personality characteristics as the sex offender against children." The average pedophile molests 260 victims during his lifetime. There are 400,000 registered sex offenders in the United States, and an estimated 80,000 to 100,000 of them are missing. Those are just the ones that are registered. There are far more than that have not been caught.

Critics of the homosexual lifestyle have predicted for a long time that once it became acceptable to identify homosexuality as simply an alternative lifestyle or sexual orientation, nothing would be off limits. Of course, for decades, "gay" advocates have been outraged at such a prediction, contending this would never happen. However, psychiatrists are now beginning to advocate redefining pedophilia in the same way homosexuality was redefined many years ago.

In 1973, the American Psychiatric Association (APA) declassified homosexuality from its list of mental disorders. In 1998, the APA issued a report claiming that "the 'negative potential' of adult sex with children was

'overstated' and that 'the vast majority of both men and women reported no negative sexual effects from childhood sexual abuse experiences"—a flat out lie. All the statistics show otherwise.

A group of psychiatrists, along with the pedophilia-advocacy group, B4U-Act, recently held a symposium proposing a new definition of pedophilia to be included in the Diagnostic and Statistical Manual of Mental Health Disorders of the APA. Following the same pattern used with all the other perverse sexual predatory evils, they are changing the name of sodomizing children. The first step in encouraging global tolerance is that you are not a "pedophile" anymore, but you are a "minor-attracted person."

B4U-Act's website states its purpose is to "help mental health professionals learn more about attraction to minors and to consider the effects of stereotyping, stigma and fear." Revealingly, they have no regard for the mental health and physical safety of the children. That is one interesting thing you find throughout all of this: There is no regard for children by the pedophiles.

It may surprise you that pedophilia has already been granted protected status by the U.S. government. I was shocked to find that out. The Matthew Shephard and James Byrd, Jr. Hate Crimes Prevention Act lists "sexual orientation" as a protected class; however, it purposely and by design does not define the term which allows it to be applied to any sexual deviancy.

Republicans attempted to add an amendment specifying that "pedophilia is not covered as an orientation"; however, the amendment was defeated by Democrats. Representative Alcee Hastings (D-FL) stated that all alternative sexual lifestyles should be protected under the law. Hastings said,

This bill addresses our resolve to end violence based on prejudice and to guarantee that all Americans, regardless of race, color, religion, national origin, gender, sexual orientation, gender identity, or disability or all of these 'philias' and 'fetishes' and 'isms' that were put forward need not live in fear because of who they are. I urge my colleagues to vote in favor of this rule. Also, the "progressives" have been ramping-up efforts to downsize from the term "consenting adults" to merely "consenting," a far less cumbersome qualifier in the deceitful advancement of unrestrained sexual license, including that with children.

Tolerating "intergenerational romance" for "minor-attracted adults" is becoming accepted these days as all the rage. Welcome to Satan's world! This isn't new; this has been going on. It is just increasing as Satan's influence is accepted more and more.

Even if a minor victim allegedly consents to what the progressive establishment has portrayed as a harmless encounter, by law, children below the age of consent cannot consent to sex with adults. Period! Right? Well, think again, because Federal law supersedes State law:

The preemption doctrine originates from the supremacy clause of Article 6 of the U.S. Constitution. This doctrine states that any federal law, even if it is only a regulation from a federal agency, supersedes any conflicting state law, even if that law is part of the state's constitution.

So, when the federal government passes something, whether the states resist or not (which many of them try to do), they have no legal standing to do so.

Pedophiles want age of consent laws rolled-back! They want the statutes which are designed to protect children from adult sexual predators thrown out! This calls to mind Hosea 4:2:

Hosea 4:2 By swearing and lying, killing, and stealing and committing adultery, they break all restraint, with bloodshed upon bloodshed. [Remember, pedophiles have the same personality characteristics as serial killers.]

It's no surprise that the "pedophile rights" movement is inexorably linked to the so-called "gay rights" movement. Here is a sampling of the gay activist's perverse argument for legalization of pedophilia: The Sexual Floodgate Is Open! by Martin G. Collins (https://www.cgg.org)

- An adult's desire to have sex with children is "normative." ("Normal" is what they say.)
- Psychiatrists should "focus on the needs" of the pedophile and should have "a minimal focus on social control," rather than obsessing about the "need to protect children."
- Children can properly be "the object of our attraction." Homosexuals further objectify children, suggesting that pedophiles need not gain consent from a child to have sex with "it"—any more than we need consent from a shoe to wear it. (That's their attitude. That is the way they look at children.)

You may think that such abject evil simply represents the fringe of today's perverse sexual "progressivism." It doesn't. It represents a popular demonic worldview. The news media has covered stories about the child-sex ring involving many of the leaders of nations. The British have been targeted by the new media, but it goes around the world. Perverts are leading us.

During President Obama's first term, the official website for the Department of Health and Human Services linked to "Parenting Tips." It referenced children as "sexual beings" and suggested that they should "experiment with homosexuality." Pedophilia is a favored activity of homosexuals. That is a fact.

Taking their demonic attacks on the family even further down the moral sewer, the Federal ruling on same-sex marriage is a constitutional argument that has opened the door to all sexual lifestyles regardless of how evil they are.

In a Newsmax TV interview on June 30, 2015, Former House Majority Leader Tom DeLay says not only is all hell breaking loose after the Supreme Court's ruling on "gay marriage," but we're on the fast track to legalizing "12 new perversions," including pedophilia and bestiality. DeLay went on to say,

We've already found a secret memo coming out of the Department of Justice. They're now going to go after 12 new perversions, things like bestiality, polygamy, having sex with little boys—and making that legal. Not only that, but they have a whole list of

strategies to go after the churches, the pastors, and any businesses that try to asset [i.e., strengthen] their religious liberty. This is coming—and it's coming like a tidal wave.

Be forewarned. Hang onto your children; watch your children and pray for God's protection every single day.

Today, people can classify themselves with any protected label of endless wicked sexual orientations under the sun, and now, pedophilia can be added to the list of protected sexual evils.

I Corinthians 6:9 (*Contemporary English Version*) Don't you know that evil people won't have a share in the blessings of God's kingdom? Don't fool yourselves! No one who is immoral or worships idols or is unfaithful in marriage or is a pervert or behaves like a homosexual will share in God's kingdom.

Clearly, this sin of pedophilia is forbidden by God since it violates the natural created order of sexual union between a husband and wife. Pedophilia is a violent, mentally devastating, and dehumanizing act of hate.

The spiritual principal from Matthew 5:28 regarding adultery also applies to any sexual sin: "Whoever looks at a child to lust for him or her has already committed pedophilia with the child in his heart." (That is a paraphrase, of course.)

Sexual union is only properly had between a husband and wife. It is never to be had between anyone else.

It's significant that a pedophile has all the sinful characteristics of those who will be burned up in the lake of fire:

Revelation 21:8 But the cowardly, unbelieving, abominable, murderers, sexually immoral, sorcerers, idolaters, and all liars shall have their part in the lake which burns with fire and brimstone, which is the second death."
