Unmasking Wolves In Sheep's Clothing

I feel truly amazed that the subject Clyde Finklea broached in his message back on February 22 ["the Pale Horse (2020)"] has continued to generate sequel after sequel after sequel, and probably will continue until this COVID-19 crisis ends. Like Richard, I shudder to know what the endgame is all about ["What's the Endgame?"]—what we will look like when it's all over. Will the leftist socialists make us all millionaires for not working, ironically ignoring their leader Karl Marx's guiding principle that labor is the source of all wealth? Will the globalist elites achieve their professed goal of thinning the world's population by 95%? Will we, like our forebears, in Egypt gullibly trade our liberty for security?

Last week, Charles Whitaker warned us about the deceit, lies, and sorcery practiced by the leaders of modern Babylon ["Whoever Loves and Practices a Lie"]. Today, the children of Jacob are foolishly bowing down to the idols of medical experts and technology. Consequently, God will send them a deluding influence so that they will believe what is false, in order that they all may be judged who did not believe the truth, but took pleasure in wickedness (II Thessalonians 2:11-12). Our Lord and Savior warned us that even the elect would not be safe from these compelling false delusions (Matthew 24:24). This commentary will endeavor to unmask some false messiahs that have pulled the wool over the eyes of much of our citizenry. The title of this message is, "Unmasking Wolves in Sheep's Clothing."

Two weeks ago, Dave Barnes sent me some links to articles and websites, exposing the nefarious intentions of some our most trusted medical experts and so-called philanthropists, revealing them not to be benefactors at all, but narcissistic dictators with a messiah complex.

The mendacious mainstream media and the leftist Silicon Valley censors (or thought police) have desperately tried to silence Dr. Francis Boyle, the one responsible for the Biological Weapons Convention, known as the Biological Weapons Anti-Terrorism Act of 1989, that was approved unanimously by both Houses of the US Congress and signed into law by President George H.W. Bush. Thankfully, because of the work of Dr. Joseph Mercola and others, transcripts of Dr. Boyle's warnings, which were censored by the media, have been unearthed.

Boyle revealed that since 9-11, the United States has spent over \$100 billion on biological warfare, a monetary outlay equivalent to the Manhattan Project, which developed the atom bomb. That entire offensive biological warfare industry has been reconstituted here in the United States with multiple BSL (Bio-Safely Level)-4 and BSL-3 labs. (Bio-safety Level 4 are facilities that handle bioweapons and highly-infectious diseases.)

BSL-4 labs, of which we have many here in the United States, are used to develop offensive biological warfare weapons with DNA genetic engineering—a kind of Monsanto GMO genetically modified product generated by the military, shamelessly assisted by respected university virology laboratories, such as the University of North Carolina at Chapel Hill and Harvard University.

Boyle informs us that well over 13,000 alleged scientists—sort of like Dr. Mengele—are diligently working on these things. The Soviet Union, for example, had previously developed anthrax as a

biological weapon. The UK, France, Israel, and China all currently participate in biological warfare systems research.

Fred Guterl's *Newsweek* article "DR. FAUCI BACKED CONTROVERSIAL WUHAN LAB WITH U.S. DOLLARS FOR RISKY CORONAVIRUS RESEARCH" (*Newsweek* is not exactly a right-wing conspiracy theory publication) revealed that one of the most dangerous aspects of a BSL-4 laboratory is known as "gain of function research" that involves taking wild viruses and passing them through live animals until they mutate into a form that could pose a pandemic threat.

Scientists used it to take a virus that was poorly transmitted among humans and make it into one that was highly transmissible—a hallmark of a pandemic virus. This work was done by infecting a series of ferrets, allowing the virus to mutate until a ferret until a ferret that hadn't been deliberately infected contracted the disease.

America's most admired savior of public health, Dr. Anthony Fauci, along with the National Institutes of Health, the CDC, The Bill and Melinda Gates Foundation, and the World Health Organization have long championed these dangerous experiments.

Dr. Anthony Fauci argued that the research was worth the risk it entailed because it enabled scientists to make preparations, such as investigating possible anti-viral medications and vaccines (developed at warp-speed, generously and lovingly financed by the Bill and Melinda Gates Foundation), vaccines that could be useful if and when a pandemic occurred.

Opposing Dr. Fauci's praise for these deadly experiments, more than 200 participating scientists called for the work to be halted, expressing alarm that a laboratory accident would trigger a pandemic. The Obama Administration, under pressure from these scientists, put a temporary halt to these experiments in 2014, but Dr. Fauci arranged for a \$3.7 million grant to continue the gain of function research at the Wuhan BSL-4 laboratory.

The communist Chinese government has often blamed America for developing the killer COVID-19 virus. Well, brothers and sisters, technically, they are correct. According to Tim Brown in his May 6, 2020 *Gateway Pundit* article titled, "Dr. Anthony Fauci Likely Broke U.S. Law When He Funded Wuhan Lab To Continue Corona Projects Banned in US in 2014," reveals that the know-how behind the weaponizing of this killer virus was developed at the University of North Carolina Virology Laboratory, conducted by a team of scientists, including Dr. Shi Zhengli, who later transferred to the Wuhan Laboratory after her work at North Carolina was suspended.

In November of 2015, the UNC Chapel Hill Office of Sponsored Research, working on bat coronaviruses, published an article in *Nature* titled, "A SARS-like cluster of circulating bat coronaviruses shows potential for human emergence."

Francis Boyle, stating that no country ever complied with the moratorium on gain-of function research, revealed that two vials of deadly coronavirus were stolen from BSL-4 laboratories in Winnipeg, Canada, this past winter and from the Harvard University Chemistry Lab, with the aid of Charles Lieber, the chair of Harvard's Chemistry Department.
